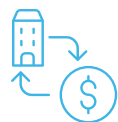

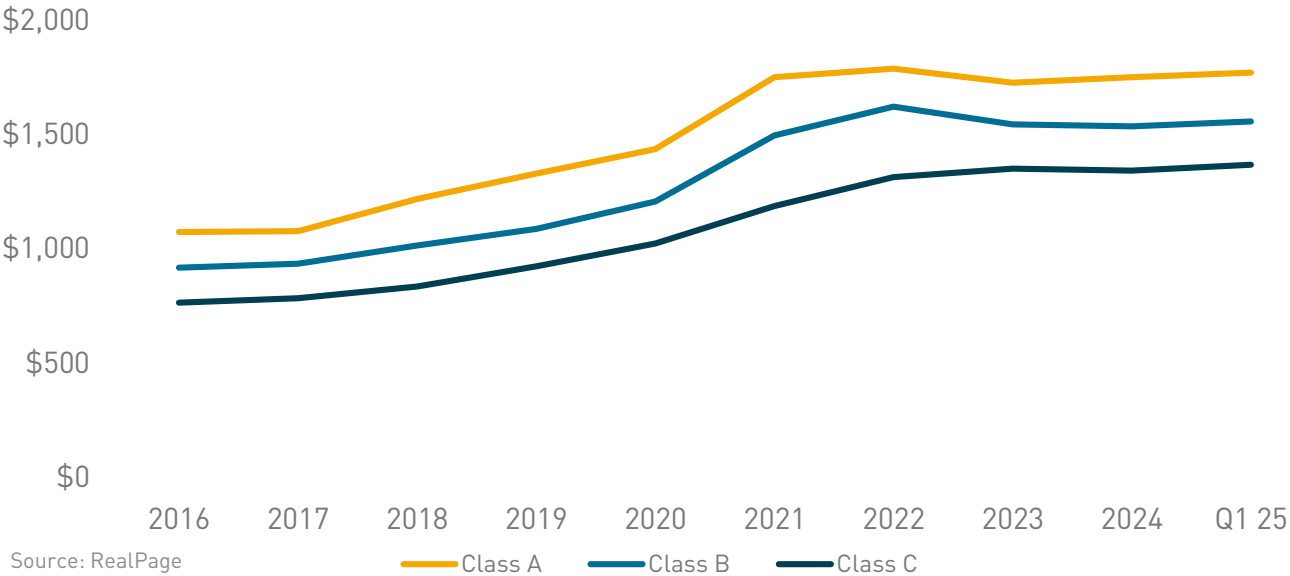
BOISE EFFECTIVE RENT BY CLASS
